## C I R C U L A R


1. All the District Secretaries are requested to ensure that the **CIRCLE CONFERENCE DONATION** at the rate of Rs.500-00 per member (as per CEC decision) be immediately remitted to the Circle Treasurer latest by 31-1-2018.
2. The delegation fee as decided in the CEC would be Rs.1000-00 per delegate to be paid at the time of conference. The fee for the observers is Rs.1500-00 per person if any other members is attending the conference in addition to delegates.
3. The Circle/CHQ quota to be cleared up to December 2016, the District quota recovered from January 2017 to December 2017 through ERP can be adjusted.
4. The outstanding dues, Diary payments etc., to be cleared immediately.
5. The voting strength of the district/division shall be determined by the quota paid at all level.
6. The number of delegates to be elected shall be ONE for every FIFTEEN paid up members and part thereof being not less than TEN subject to a minimum one for Branch/District/Division. [ (Art 9(a)(i))].

7. CHQ office bearers/Circle office bearers/CWC members/CEC members/District/Division Secretaries shall be ex-officio delegates sharing the voting strength of Branch/District/Division to which they belong. [ (Art 9(a)(i)) ]
8. The Branch Secretaries must be one of the delegates from the branch in lieu of one of the justified delegates. [ (Art 9(a)(i)) ].
9. Delegates may come prepared with all information on both organizational and service matters/suggestions etc.,.
10. The venue of the conference is about 2 KMs from the Bus-stand and 1 KM from Railway Station.
11. The accommodation for the CEC members shall be available from the afternoon of 23rd Feb 2018 up to 7 am 26<sup>th</sup> Feb 2018.
12. The accommodation for the delegates will be available from 7 am of 24<sup>th</sup> Feb 2018 to 7 am of 26<sup>th</sup> Feb 2018.
