- (vii) They have fulfilled the prescribed eligibility of three years regular service as per SDE (T) RR.
- (viii) The officer has submitted the under taking as per the enclosed format.

2. If any of the above conditions noticed, the same may be brought to the notice of this office immediately for taking further action with BSNL Corporate Office.

3. All the promoted officers are instructed to join their promotional assignment within the prescribed time limit of 40 days (including joining time) from the date of issue of BSNL order dated 25.05.2018 & 30.05.2018.

4. . In case the officers concerned fails to join the promotional assignment within the prescribed period of 40 days, he/she should not be allowed to join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.



8. Pay fixation on promotion be done as per prescribed norms.


